2. Hazards Identification

Emergency overview: Caution. Can cause irritation to skin and eyes. May be harmful if swallowed.

EYE CONTACT: May cause irritation, redness, tearing.

INHALATION: No significant effects expected from short-term exposure.

INGESTION : Can cause nausea, vomiting and gastrointestinal upset.

SKIN CONTACT: Can cause irritation to sensitive skin upon prolonged contact.

4. First Aid Measures

EYES: Immediately flush eyes with a direct stream of water for at least 15 minutes. Hold eyelids apart to ensure complete irrigation of all eye and lid tissues. Get medical attention.

INGESTION: If swallowed, DO NOT induce vomiting. If victim is fully conscious, give large quantities of water to drink. Never give anything by mouth to an unconscious person. Get medical attention immediately.
