#### 2. Hazards Identification

Emergency overview: DANGER. Corrosive. Causes irreversible eye damage and skin burns. Harmful if swallowed, inhaled or absorbed through the skin.

PRECAUTIONARY STATEMENTS: Avoid breathing spray mist. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves and protective clothing when handling. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing and wash clothing before reuse.

### SIGNS AND SYMPTOMS OF EXPOSURE (SKIN, EYE CONTACT; INHALATION; INGESTION)

EYE CONTACT: Causes burns and may result in permanent injury to eyes including blindness.

INHALATION: Mists and vapors can irritate the throat and respiratory tract. High vapor concentrations may cause

central nervous system effects. Symptoms may include headaches, dizziness, and drowsiness. Harmful if

inhaled.

INGESTION: Although relatively low in toxicity, ingestion can cause gastrointestinal irritation, swelling of the larynx,

difficulty in breathing, circulatory shock, convulsions and possibly death.

SKIN CONTACT: Causes corrosive burns. Brief exposures may cause irritation and defatting of the skin. Exposures not

promptly washed off may lead to toxic effects similar to ingestion. Harmful if absorbed through the

skin.

#### 4. First Aid Measures

*EYES:* Immediately flush eyes with a directed stream of water for at least 15 minutes. Hold eyelids apart to ensure complete irrigation of all eye and lid tissues. Washing eyes within several seconds is essential to achieve maximum effectiveness. Get medical attention immediately.

*INGESTION:* Call a poison control center or doctor immediately for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person. Note to physician: Probable mucosal damage may contraindicate the use of gastric lavage.

*SKIN CONTACT:* Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

*INHALATION:* If symptoms are experienced, move victim to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

## 5. Fire Fighting Measures

FIRE FIGHTING METHOD: Move container from fire area if it can be done without risk. Cool containers with water. Avoid contact with skin and wear NIOSH approved breathing apparatus.

EXTINGUISHING MEDIA: Use extinguishing agents appropriate for surrounding fire.

UNUSUAL FIRE OR EXPLOSIVE HAZARD: Irritating and toxic gases or fumes may be released during a fire.

#### 6. Accidental Release Measures

PERSONAL PRECAUTIONS: Isolate area. Keep unnecessary personnel away.

ENVIRONMENTAL PRECAUTIONS: Keep out of sewers, storm drains, and waterways.

CLEAN-UP PROCEDURES: Only trained and properly protected personnel should be involved in spill clean-up operations. Wear alkaline-resistant suit and complete protective equipment; rubber gloves, rubber boots, and chemical goggles. Use a non-combustible material like vermiculite, sand, or earth to soak up the product and place material in sealable waste containers for disposal.

# 7. Handling and Storage

HYGIENIC PRACTICES IN HANDLING AND STORING: Avoid contact with skin and eyes. Use good personal hygiene practices.

PRECAUTION TO BE TAKEN IN HANDLING AND STORING: Store in cool, dry, ventilated areas. Do not handle or store in an open flame, heat, or other sources of ignition.

DISPOSAL OF EMPTY CONTAINER: Empty containers should be triple rinsed with water and disposed of pursuant to Local, State and Federal requirements.

*RESPIRATORY PROTECTION:* If ventilation is not sufficient to effectively prevent buildup of vapors, appropriate NIOSH respiratory protection must be provided.

EYE PROTECTION: Chemical safety goggles and face shield to protect against skin contact when appropriate.

PROTECTIVE CLOTHING: Rubber gloves, rubber boots and full length clothing.

VENTILATION: Provide local exhaust ventilation.

OTHER PROTECTIVE MEASURES: Eyewash fountain and safety shower are recommended.
